

President's Message

This will be our last issue of the *Pioneer Press* this year, so I am providing a brief summary of what we've accomplished, along with a bit of cheerleading for the "last

quarter."

The year has seemed to fly by (which should be a note of encouragement for those of you who are in the "presidential lineup" and others who may consider becoming candidates). Serving as Pioneer President has been a very enjoyable activity for me.

Presidential Goals

My personal goals for the year were primarily to support and continue the projects in which we were already engaged, including (a) preservation of our own, as well as CEC's, history and archives, and (b) support and enhancement of the joint CEC-CEC-PD Mentoring Program. Toward those ends, I have communicated--often and perhaps sometimes ad nauseum -- with PD Board members, our membership, CEC staff and officers, board members of other divisions, and anyone else who dared send an email in my direction. I have provided information about our activities for *CEC Today* and our own *Pioneer Press*. I have assisted in the writing of articles for newsletters of other organizations or agencies. I have also responded by telephone or email to any individuals who have asked questions about general conditions in the field of special education or the children we serve.

Our PD Board has recently approved the appointment of Diane Johnson as Historian, and, although her five-year term begins on January 1, 2012, she has already visited CEC Headquarters to assess her task and begin the work. We are also contacting several

organizations and institutions who are conducting their own work on special education history, in order to provide links to other entities that can make a contribution. Our professional sessions during the International CEC Convention have also addressed historical perspectives in our field.

Treasury Enhancement

Since our treasury depends on membership dues and we're the smallest (and therefore the poorest) CEC division, we made an effort toward fund-raising this year. We held a donation/drawing (with a very nice prize--a free week's housing on the Outer Banks). The generous donor of the vacation home (my brother, Captain Arthur Carden, USN, retired) has said that he might even do that again, and we look forward to that. Louis Tutt of Arlington, Virginia, was our winner, and he has recently contacted us to say that he will take advantage of his prize in the Spring of 2012 (See part of his message in the "Keeping in Touch" column).

Redesigning our Future

To help us in future planning, President-elect Bill Bogdan conducted an all-day meeting during the CEC Convention last April in National Harbor, Maryland. This was followed by a survey of a large number of CEC members (some of which were members of CEC-PD and some of which were not). The survey was conducted by Lyndal Bullock, PD Vice-president, and Lynn Ziraldo, our representative of the CEC Assembly. Executive summaries of the survey results will be provided by Bill Bogdan for the next issue of *Pioneer Press*.

One finding of particular interest to me is that many CEC members have never heard of us and have no idea about what we do. The Division News section of *CEC Today* is our primary way of communicating with all CEC members. I do realize, however, that many CEC members do not prefer the Internet as a means of communication.

I am, therefore, taking this opportunity to issue a call to all our members to make some personal contacts with eligible CEC members – to make them aware that we do exist, we have some great service projects going, we're having a good time, and we need their help.

Update - CEC/CEC-PD Mentoring Program

The CEC/CEC-PD Mentoring Program is in the beginning stages of its fifth year.

This year, there are 127 mentors involved in the Program, including 20 mentors who began mentoring during the Pilot five years ago. Seventeen universities and colleges are participating; an increase of two from last year. Three faculty advisors from these participating student CEC chapters also serve as mentors. It is anticipated that there may be as many as 135 mentees included in this year's Program; an increase of 34 from 2011-2012.

Currently, the Program is involved with conducting the process of matching the mentors to mentees based on areas of special education practice (LD, DD, etc.), age levels of students (early childhood, middle school, etc.), and geographic location.

Mentoring will continue to be conducted primarily using e mail; a true virtual mentoring experience. However, several of the mentors are exploring using more "personal" alternatives such as Skype, video conferencing, etc.

The Program will once again be partnered with the IDEA Partnership which provides a rich source of vetted information for the mentors to use as resources with the mentees during the mentoring process.

Here's to another productive year in the CEC/CEC-PD Mentoring Program!

In Memoriam:

Chuck Heuchert 1933 – 2011

Charles M. Heuchert died on September 20, 2011 in Waynesboro, VA, Professor Heuchert, who was known as Chuck by many friends and colleagues, was born on 30 August 1933 in Henning MN, to Karl and Amanda Lueker Heuchert. He was a veteran of the United States Air Force and a four-time graduate of the University of Michigan, completing Ph.D. studies in 1969.

After teaching engagements at Syracuse University, the University of Michigan, and Eastern Michigan University, Chuck joined the faculty at the University of Virginia. He was a member of the faculty at U.Va. in the special education program from 1969 through his retirement in 1998, serving in various capacities including assistant and then associate dean for undergraduate studies and licensure.

Throughout a career that began as a teacher and spanned 40 years, Chuck was an active advocate for students with emotional and behavior disorders and a champion of compassion and caring for student's emotional needs, promoting child-centered methods such as Life-Space Interviewing and Reality Therapy.

In 1973 Chuck co-authored *Pain & Joy in School* with Edward W. Schultz and Susan M. Stampf and in 1983 he co-authored *Child Stress and the School Experience* with Schultz. In 1987-88 he served as president of the International Council for Exceptional Children, the world's largest organization devoted to improving services for individuals with disabilities and the gifted.

His favorite charities were Camp Holiday Trails, 400 Holiday Trails Lane, Charlottesville VA 22903; and First Presbyterian Church Preschool Scholarship Fund, P.O. Box 877, Waynesboro, VA 22980.



William C. Rhodes 1918 – 2011

William C. Rhodes, II, died on February 18, 2011, in The Villages, FL. Professor Rhodes, who was born on November 14, 1918, in Willets, LA, had a long career advocating for alternative perspectives about emotional and behavioral disorders.

Before his academic career, Professor Rhodes served in the US Army, achieving the rank of Captain. He completed bachelors and masters degrees at Emory University and took a doctoral degree in psychology from The Ohio State University. Professor Rhodes began his academic career at Vanderbilt University in the 1950s, working with Nicholas Hobbs. He then joined Eli Bower at the National Institute of Mental Health before going to the University of Michigan. After teaching and conducting research at the University of Michigan until 1980, Professor Rhodes finished his academic career as a senior scholar and visiting professor at the University of South Florida, where he taught until 2005.

An early paper in *Exceptional Children* by Professor Rhodes established his views about the reciprocal connection between children and their communities. Professor Rhodes' work on the Conceptual Project in Child Variance while at the University of Michigan in the early 1970s had substantial impact on special education for children and youth with emotional and behavioral disorders (EBD). The project resulted in a multi-volume publication called *A Study of Child Variance* that presented perspectives on EBD based on conceptual models popular at that time—biological, behavioral, psychodynamic, sociological, and ecological—and that ultimately set him on a path to adopting a view that taking a critical view was better than taking any particular theoretical view. His early-career interest in ecological approaches progressed into a later-career embrace of liberatory theory and post-modernism.

Professor Rhodes was the son of William and Nell Rhodes. He is survived by his wife, Estelle Smith Rhodes, whom he met and married in 1942; their children William Rhodes, III, Joseph Rhodes, Naomi Rhodes, and Trisha Rhodes; siblings; and eleven grandchildren.

Dr. Sage will be presented with the award at the fall college-wide orientation for students and faculty. Dr. Sage has also agreed to deliver a workshop presentation for students.

After residing and working in the greater Cincinnati area for the past 35 years, Bill Bogdan and partner Carl Ward have recently relocated to the mountains of western North Carolina. Over the past year, Bill and Carl have completed building their mountain retirement home and are transitioning to a new life in the Asheville, North Carolina area – and, just in time for the autumn change of color!

Lee Sherry of UNC Charlotte is completing two years as Chair of the North Carolina Special Education Cooperative Planning Consortium (CPC). The CPC consists of the state's 22 public and private college and university personnel preparation programs in special education. The Consortium meets twice a year to examine existing resources to assist public schools and agencies meet personnel needs.

Preserving CEC's History

The June Jordan Fund was established in 1994, by the Pioneers Division in honor of June Jordan who was a former CEC staff member. June was instrumental in providing the leadership and support for establishing the Pioneers Division. In addition, she led CEC in the collection of documents and other types of information of historical significance to CEC and the field of special education.

The official title of the fund is "The June Jordan 'I have a Dream' Memorial Fund". The purpose of the fund is to support CEC in maintaining the Archives and history of the Council. The Archives are maintained by a CEC Archivist who holds a non-voting position on the CEC-PD Board. The Fund is supported by direct contributions to the Fund. These funds are then allocated for expenditures to support the expansion and maintenance of the CEC Archives.

In the past, the support for the CEC Archives consisted of providing dollars from the June Jordan Fund to purchase supplies needed by the CEC Archivist, and to provide assistance to the Archivist by other members of the Pioneers Division in preparing and in placing materials in the CEC Archives. It is hoped that the plan developed by the History Initiative Work Group will provide additional opportunities to share, as well as, preserve the history of CEC and CEC-PD.
