Summary Report on CEC-PD Goals for 2010 Diane Johnson, CEC-PD Immediate Past President

1. To increase membership in CEC-PD through an active plan for recruitment and retention of members

Membership is critical to the Division. Under the direction of Membership Chair, Pat Seibel, the Membership Committee developed a plan for membership development. A pilot has begun in Pennsylvania and Florida to contact potential members directly. There will be a CEC-PD presence at the upcoming convention at National Harbor in conjunction with CEC Central. Increasing membership, especially during these difficult times will continue to be an area that requires focus.

2. To continue support for the joint CEC/CEC-PD Mentoring Program

The CEC/CEC-PD Mentoring Program has continued to expand. The program continues to provide visibility for the Division and was featured in a recent issue of *CEC Today*. A detailed report of the program and the most recent evaluation was completed in September.

3. To provide a bridge between past history and future development of CEC

The formation of the CEC-PD Work Group on Historical Initiatives was approved by the Board, and has been busy during the past year to complete its assigned purposes: to identify/locate current historical files and information related to CEC and CEC-PD; to determine ways in which the history can be preserved and shared; and to develop a plan that will provide a bridge to link the past to the future with suggested activities and possible timelines. The recommendations of this work group may lead to some additional initiatives that can provide opportunities for greater involvement by CEC-PD members and provide another avenue for CEC-PD to be more visible within the CEC organizational structure.

4. To increase the use of electronic means of communication across CEC-PD as well as with other CEC Divisions and organizational units

CEC-PD has continued to use electronic means for conducting business. As a result a large amount of business has been completed using this format. Because there is only one face to face meeting each year, this has greatly enhanced the ability of the Board to engage in a more active program of work. The

CEC-PD newsletter, *Pioneers Press*, has provided the option for members to receive the newsletter electronically. As more members select this option, there should be a financial savings in the printing and mailing of the newsletter. An email account, cecpdnews@gmail.com, was also established, and this may develop into a means for contacting the Division for general information and to share news and other items. The CEC-PD Member Directory continues to also be offered to members in electronic format as a requested benefit.

5. To increase member participation and leadership opportunities within CEC-PD that also capitalize on the membership diversity

Opportunities have been provided for members to serve on committees, work groups, and to represent PD on special committees. We need to continue to expand these opportunities.

On a personal note, I would like to thank all of the CEC-PD members who were willing to take an active role in our organization, and also to thank those who are active through their continued membership. I have appreciated the opportunity to serve as your President, and look forward to seeing many of you at the annual convention and expo in April.

BIOGRAPHICAL INFORMATION FOR THE CANDIDATES

VICE PRESIDENT (2012)

JANET BURDICK, IDAHO

Janet Burdick has been a Director of Special Education in two districts. She has also been a consulting teacher. In 2007 she was the recipient of the Professional Achievement Award, College of Education Idaho State University.

Janet's education includes a Bachelor of Arts in Spanish at the University of Colorado, and a Master's Degree in Advanced Exceptional Child at Idaho State University. She also has a Consulting Teacher Endorsements, a Secondary School Principal Administrative Certificate and Director of Special Education Administrative Administrator Certificate all from Idaho State University.

Janet was the international CEC president in 2003. She was also Governor at Large, U.S. and Idaho Unit President. She has participated in the CEC/CEC-PD Mentoring Program since its inception.

If elected as the Vice President of the Pioneers Division, Janet has indicated that her goals for CEC-PD would be as follows:

- Expand the mentor/mentee program especially in the west and internationally as practicable.
- Increase CEC-PD membership to include "younger" pioneers.
- Utilize the experience and expertise of CEC-PD members to advance public policy advocacy.
- Work alongside CEC Board of Directors to promote CEC's strategic plan.

JAMIE HOPKINS, OHIO

Jamie Hopkins is currently Field Supervisor/Adjunct Instructor, University of Cincinnati, OH (since 2007). She previously served in a number of roles including: teacher and students with disabilities; supervisor of special education; director of student services; and coordinator of special education.

Among Jamie's contributions to education in Ohio, are: she participated on Ohio Issues Task Force, in county-wide Autism Task Force; and in district planning and implementation of an Intervention Based Assessment Model (precursor to Response to Intervention Model); served on Ohio Learning Outcomes Panel, appointed by the governor to develop new standards for Ohio's schools.

Jamie has served in many CEC positions at various levels including President of student, local chapter and Ohio CEC organizations; Ohio Governor for CEC Board of Governors; Member at large CEC Board of Directors; President CEC; and was a member/chair of several CEC committees (e.g. Nominations Committee, Finance committee). Her experience with PD has been as a member of the Mentor Project for the last two years.

If elected as the Vice President of the Pioneers Division she "would like to expand the mentoring program to include aspiring leaders within CEC and postgraduate students who are working in areas of administration or higher education. The Pioneers could also provide opportunities to share their experience and expertise with CEC workgroups and committees as they advocate for the needs of exceptional children and their families"

Education Officer, Supervisory Officer, Director of Education; University lecturer in the field of special education (teacher training) – McGill University, University of Ottawa, Queens University.

Hellen has published "Curriculum/Evaluation Strategies for Basic and General Level Students," a School Board Publication. She has also written articles for CCEC and Ontario CEC newsletters.

Hellen has served in all local chapter positions and Ontario CEC Federation positions including treasurer, vice president, president elect, president and past president. She has been on the CCEC Board of Directors as Member at Large and Governor. For International CEC, she has served on the Board of Governors and CEC Board of Directors. Helen has been International CEC President.

She has been an active member of Ontario CEC-PD. Helen has attended provincial conferences and helped with nominations for awards. She serves as a mentor to two university graduate students. Hellen's goal statement for CEC-PD is as follows:

"The Pioneers are struggling to maintain membership I would actively support the direction of PD executive committee in exploring the concept of divisions in their role within CEC. Review the mission, the core functions, the purpose etc. Declining membership leads directly to few financial resources and therefore programs and services are curtailed. As treasurer, I would investigate other means of generating revenues. We need to ask the question: how can CEC-PD best served the council? The expertise within the Pioneers membership is vast. CEC-PD can and should lead in this direction."

Michael Thew is currently serving as the Executive Director of the Lincoln Intermediate Unit 12 (one of 29 educational service agencies in PA).

Michael started his career as a classroom teacher for students with severe mental retardation and then worked with elementary developmentally delayed students. He then became a Supervisor of Special Education Services for the Lincoln Intermediate Unit 12 in Pennsylvania for 13 years, followed by eight years as an assistant superintendent and superintendent of the Eastern York School District in Pennsylvania.

Michael has served as local officer (all levels) for the local Pennsylvania CEC chapter. He has also served in every office of Pennsylvania CEC including being president in 1994.

Michael has served as the Pioneer CAN representative and is currently the Treasurer for the Pioneer Division.

THE 2010-2011 CEC/CEC-PD MENTORING PROGRAM

The current year of the Program includes the largest number of participants thus far. There are ninety-nine mentors from the United States and Canada with twenty mentors having been with the Program since its initiation; fifteen universities and colleges; and one hundred one mentees. In addition, there are mentees involved this year who were also mentees last year. Both undergraduate and graduate students participate in the Program.

The Program is now linked with the IDEA Partnership of which CEC is an active member. This affords mentors access to additional cutting edge materials that can be shared with the mentees during the mentoring process.

A Facebook page has been developed for the Program. Content information emails are distributed on a regular basis to the mentors so that this information can be shared with their mentees where appropriate.

A professional program session will be offered at the April CEC convention focusing on the findings of conducting a virtual mentoring program as well as the sharing of some personal experiences by the mentors and mentees who have been involved with the Program.

Romaine P. Mackie Annual Award for Leadership

A brief vitae or resume' for the individual nominated which shows educational background, places of employment, length of service, special projects undertaken, awards received, other information which might assist the Awards Committee in making a decision, and at least two (2) letters of support, but not more than four (4).

All nominations and materials must be received by January 31, 2011.

Preserving CEC History and Linking to the Future Important CEC-PD Activity

The June Jordan Fund was established in 1994, by the Pioneers Division in honor of June Jordan who was a former CEC staff member. June was instrumental in providing the leadership and support for establishing the Pioneers Division. In addition, she led CEC in the collection of documents and other types of information of historical significance to CEC and the field of special education. The official title of the fund is "The June Jordan 'I have a Dream' Memorial Fund". The purpose of the fund is to support The Council for Exceptional Children in maintaining the Archives and history of the Council. The Archives are maintained by a CEC Archivist who has a non-voting position on the CEC-PD Board. The Fund is financed through direct contributions to the Fund. These funds are then allocated for expenditures to support the expansion and maintenance of the CEC Archives. In the past, the support for the CEC Archives has consisted of providing dollars from the June Jordan Fund to purchase supplies needed by the CEC Archivist, and to provide assistance to the Archivist by other members of the Pioneers Division in preparing and in placing materials in the CEC Archives from time to time. It is hoped that the plan developed by the History Initiative Work Group will provide additional opportunities to share, as well as, preserve the history of CEC and CEC-PD.
