# Report on the Pioneers Division Design Workgroup

On September 16, 2010, a special division workgroup was approved and commissioned by the executive board of the Pioneers Division. The design workgroup was charged with developing a division redesign proposal that would be presented to the board at the April 26, 2011, board meeting.

The design workgroup met on April 25, 2011, reviewed historical information, current financial information, and membership data, and from those reports, explored strategies for improving services to its members and to the Council for Exceptional Children.

The current mission and purpose of the Pioneers Division is to serve "as a professional educational organization which is a division of the Council for Exceptional Children. The primary purpose of CEC-PD is to provide a service to the Council for Exceptional Children and bring recognition to those who have been members of CEC for twenty (20) years or more. Specifically, the Pioneers intend to assist and provide support to CEC in all efforts on behalf of children and youth with exceptionalities by: 1) responding to and addressing emergent and critical issues in the field; 2) advocating on behalf of children and youth with exceptionalities; and 3) participating in all appropriate governance activities of CEC. CEC-PD will encourage research, promote professional development, and support those who serve children and youth with exceptionalities."

Since 2007, a clearly articulated set of goals and objectives have supported the division's attention to membership growth, improved communications with members, supporting and organizing the CEC archives, and piloting, expanding, and coordinating with CEC the Council's Mentoring Program.

Several areas for attention and improvement were identified by the workgroup:

- Strengthening and building new links and bridges with and across the CEC division and with CEC Pioneers Division's own subdivisions,
- Strengthening communications with CEC-PD members through the use of technology, membership surveys, newsletters, and convention activities,
- · Expanding division programs and services such as the very successful mentoring program, and
- Building division vitality through membership and revenue growth.

Four critical priority areas were identified that will guide the work of the division over the next year. These priorities will build on the exceptional talent within the division, will build bridges with CEC and its units, and will strengthen the mission and purpose of the division as work continues in exploring a next vision for the years to come. Priority areas include:

- 1. Enhancing and expanding the CEC Mentoring Program in cooperation with CEC and its units,
- 2. Exploring ways to build on the talents, experience, and skills of Pioneers' members to assist CEC with its emerging strategic plan,
- 3. Support and enhance the CEC archives and explore with CEC ways to build the rich archives through oral histories and stories of the Teachers of the Year and other CEC award recipients,
- 4. Support and promote the CEC Yes I Can! student awards program (in cooperation with CEC, the Honors Committee of the Council, and the Honors Committee Yes I Can! Subcommittee.

As the workgroup continues to develop strategies for enhancing the Pioneers Division programs and services, highlights and updates will be shared through the Pioneers Press and communications to members.

# Linda Marsal, Pioneers 2011 Romaine P. Mackie Leadership Award Winner



On Wednesday evening, April 27 in the crowded, noisy and festive Moon Bay Coastal Cuisine restaurant in the Gaylord Grand Hotel in National Harbor, Maryland, Linda S. Marsal was awarded the 2011 Romaine P. Mackie Leadership Award. Mike Weinroth, Chairman of the Honors and Awards Committee made the presentation as nearly 50 Pioneer members awaited to hear the name of this year's winner. In his presentation Mike observed that in that small area were collected former and current leaders of the Council for Exceptional Children-Presidents, Governors and decision makers at every level of the organization. Selecting excerpts from support letters to the Honors and Awards Committee, Weinroth shared that "this nominee has been

dedicated to developing the leadership of those with whom he or she works. The nominee seeks out individuals who he or she believes has emerging leadership skills, connects with them, nurtures them, and supports them as they work. There is always encouragement offered. There is an insistence on excellence. Everyone is held to a high standard of performance. This recipient's legacy is a host of emerging leaders who model skills, judgment, and thoughtfulness."

Another letter stated that "the nominee as president of CEC believed that this position included not only being a representative of the general CEC membership, but also a manager of the various operations of the governance within the organization. A hallmark of this person's tenure as president was the appointment of a task force to study the conditions of teaching within Special Education. As a result, a report was generated that spoke to the conditions of teachers, both good and bad and the task force report offered ways to support positive conditions-but it also spoke to addressing the challenges."

The Council for Exceptional Children Pioneer Division was privileged this year to have as our Showcase Session Presenter and Honoree, Dr. Donald Deshler, the Williamson Family Distinguished Professor of Special Education and the Director of the Center for Research on Learning at the University of Kansas.

It was described as an honorable tribute to Dr. Deshler, fun, informative, a learning experience and one of the best sessions of the convention program. Session Leader Gerry Reynaud, new member of the PD Board of Directors was selected by President Elect Bill Bogdan to host this session. Early in this session Reynaud made it clear that the Pioneer Division was most interested in honoring Don for his decades of significant dedication to advance teaching and learning through outstanding research, educational strategies and intervention all guided by research and compassion for the human spirit to learn and achieve.

Deshler was described as a Level 5 Leader according to references from Jim Collins best seller "Good to Great." Such leaders build enduring greatness through a paradoxical blend of personal humility and professional will. They are a study in duality, modest, willful, humble and fearless, just to mention a few characteristics of Level 5 leaders.

We also had special (surprise) guest contributors to the honor's portion of this session. Invited and more than willing to participate were Alexa Posny, Ph.D, Assistant Secretary, United States Department of Education, Office of Special Education and Rehabilitative Services and Dr. Doug Fuchs, Department Chair of Special Education, Vanderbilt University and CEC Convention Program Co-Chair 2010 and 2011. Both speakers validated the significant contributions and sustaining effects that the work and leadership of Don and the Kansas University Center for Research has had on the field, professional educators, exceptional children and their families.

Following the Honors portion of this session Dr. Deshler made a presentation titled: Attempts to Move the Needle on Adolescent Literacy: A 30 + year Journey. This session was difficult to end as there was so much interest in the content, relevance and profession manner of our prestigious presenter. The CEC Pioneer Division congratulates and expresses our appreciation to Dr. Deshler for his acceptance to serve as our Show Case Session presenter for 2011.

The CEC-Pioneers' parts of the CEC Convention in National Harbor all went very well. We started the week on Monday with a serious but enjoyable work group meeting, with President-elect Bill Bogdan presiding. We spent the day going over the work of several committees that had addressed where we'd been, where we are, and where we should go from here. At the end of the day, we came to several conclusions--that we have an important role to play within CEC, that we are ideally suited to do the tasks we have chosen for ourselves, and that we need more members of both our division and others to join us in carrying out our projects.

Tuesday was "Division Day" at the convention. We began our day with our Mentoring Program Breakfast, which was supported by both CEC and CEC-Pioneers., This was followed by a full day of meetings of the Pioneer Executive Board, the Annual Business Meeting, and our Annual Dinner. During the dinner, the Romaine Mackie Award was given to Linda Marsal (See Mike Weinroth's report on the award presentation elsewhere in this newsletter). Also on Tuesday, Pam Gillet led a professional session on the topic of our Mentoring Program. Another professional session, "Pioneering Parents' Experiences in Special Education Process and Advocacy," was scheduled on Thursday. Also on Thursday was the meeting of the Interdivisional Caucus, at which CEC-Pioneers was well-represented by Eleanor Guetloe, Bill Bogdan, Lyndal Bullock, and Diane Johnson, Vice-chair of the IDC.

Throughout the convention, on an unscheduled and unplanned basis, were occurring probably the most important moments of all--the opportunities to visit with many of our friends and colleagues, whom we get to see only once a year--at CEC Convention.

#### 2010-2011 CEC/CEC-PD MENTORING PROGRAM REPORT

The fourth year of the CEC/CEC-PD Mentoring Program has concluded. Thirty nine new mentors were recruited for the Program this year, making a grand total of 99 mentors. Twenty mentors have been with the Program since its inception four years ago.

Five new colleges/universities joined the Program resulting in 101 mentees from 15 CEC student chapters. Mentees' interests covered all areas of disabilities classified under IDEA; preschool through transition; and specialty areas of ELL and speech and language. Fourteen mentees were graduate level students; many with an interest in administration.

The Mentoring Program joined the IDEA Partnership this year. This union provides the mentors with cutting edge materials and resources that are vetted; linkages to resources developed by other organizations and state agencies; and access to the various Dialogue Guides and the Collections developed by the Partnership. Mentors used these materials to enhance their own professional development; provide relevant information to their mentees based on the mentees' areas of interest; share with professional colleagues in their respective districts/organizations; and to form the basis of some of the mentoring sessions conducted during the year.

A Facebook page was created for the Mentoring Program and is managed by Debbie Wichmanowski, a Pioneer member and a charter mentor. This provides a place where mentors can exchange information and make queries of other mentors.

The CEC/CEC-PD Mentoring Program once again held a breakfast meeting at the recent CEC convention for all mentors, mentees, CEC staff, and faculty advisors involved in the Program. This activity provided an opportunity for some of the mentors and mentees to meet, personally, for the first time as 95% of the actual mentoring is virtual....independent of a set schedule and geography.

In addition, a CEC program session was devoted to the Mentoring Program where the organization of the Program was described; findings concerning conducting a virtual mentoring program based on the four years of this Program's operation reviewed; and the results of the annual evaluations shared. The session also included a panel comprised of three mentors with their mentees and a faculty advisor who discussed the benefits, challenges, and the impact of the Program from their personal perspectives.

It is anticipated that the CEC/CEC-PD Mentoring Program will expand next year and additional mentors will be needed. The time involved in mentoring ranges from 1-2 hours per month and results in many benefits to both mentors and mentees. If you are not a mentor now, I invite you to become involved. # Summary Based on March 3, 2010 CEC CAN Coordinator Conference Call

#### Policy and Advocacy Services

Lindsay Jones, of CEC Policy and Advocacy Services, shared current information focusing on Congressional recent actions and current plans related to special education funding issues:

# The two major positive talking points to emphasize: with Congress are:

- 1. Polls continue to show hat Americas are "strongly opposed to cuts in Education."
- 2. Education spending is such a small portion of the cuts needed to reduce the deficit that cuts in education spending should be spared.

#### HR 1 included \$547 million in cuts to IDEA

The House, based on the number of calls and responses received, accepted amendments saving IDEA, but cutting 'Teacher Quality Grants' and "State Improvement Grants." The Javits funding for gifted was also retained. The Senate rejected HR 1 by a 56-44 vote.

The House now has proposed to cut \$2 Billion per week, including the Striving Readers and Even Start programs. Their focus is on the 13% of the budget, which is made up of "discretionary" funding," including all of the budgets for Health & Human Services and the Department of Education. In contrast the military, Medicare, and Social Security are considered non-discretionary" funds for the military, Medicare, and Social Security. Thus, eliminating all education funding would not begin to offset the 900 billion budget deficit.

Therefore, CEC stresses that "education is <u>not</u> what the budget deficit requires" because it is only a small portion of the cuts needed.

# Overall, CEC feels that the political climate is becoming worse, and more hostile.

No programs are safe from cuts and all are operating in "defensive mode. Examples include:

ESEA: although there is a new class of elected officials, not all are favoring drastic cuts.

Vouchers: are seen as expensive, especially for special education services.

Education and Labor Committee: renamed Education and Workforce Committee.

IDEA Part B: a \$500 Billion cut has been proposed.

HR1: Voting on amendments every 2 minutes has led to voting errors by members.

# What can CAN and CEC members do?

- · Make Congressional visits during the CEC Convention, which will be nearby.
- Send CEC stories about how cuts are affecting special education services.
- Watch e-mails for times when CEC needs member support and help.
- Be ready to demonstrate effective programs to help turn the tide toward rather than against teachers.
- Keep in mind family, health, and related issues that also impact special education students.

#### OUTSTANDING PUBLIC SERVICE AWARD

The Council for Exceptional Children (CEC) presented its Outstanding Public Service Award to Sen. Tom Harkin of Iowa during the recent annual meeting of its Children and Youth Action Network (CAN), which brings together special educators from around the country for advocacy and public policy training, briefings, and congressional visits. Harkin, who has been in the U.S. Senate for more than 30 years, has "consistently worked to ensure that individuals are not defined by their disabilities and are afforded the same rights and opportunities as all Americans," said Bruce A. Ramirez, CEC's executive director.

### Report of the Representative Assembly

DAY 1 a quorum was determined and the meeting began.

President Marilyn Friend thanked the reps for being here + their contributions and critical leadership. A review of the purpose of the RA and how it would shape the CEC was discussed. President Friend reported the highlights of the strategic plan; the CEC public policy plan; the annual convention and expo; the Riga Conference conducted by DISES; constitution and by-law # 3 changes; use of CEC restricted funds; and directors activities. The 2012 Local arrangements Chair in Denver, Gina Quintaine, was announced as was the 2016 Convention site will be in St Louis, MO. The CEC values, mission, vision and core values were approved by the RA.

Discussion on 2012 – 2014 Strategic Plan on goals, issue statements and objectives. Pioneers gave several comments on this discussion as it was reviewed at our Pioneer Board meeting. In addition gave input on School Vouchers and Charter Schools as the positions of CEC were being reviewed to now be a policy statement.

Bruce A Ramirez, Executive Director of CEC, gave an overview of the highlights since the last convention. He introduced the staff executive team, reviewed the yearend summary of 2010 Strategic Plan in the following areas: teaching and learning conditions; Evidence based practices; international engagement; community and membership; public policy advocacy; organizational effectiveness: and, membership. Membership has 3.1% increase new members and a 5% increase retention rate. Membership dropped by 714. Currently membership is 34,878. Dr. Ramirez highlighted the 2011 strategies for the Strategic Plan and made collective collaborative leadership his message.

Key points of the treasure by Jim Heiden indicated a healthy financial picture for the organization. Registration amount for convention will not increase next year. 5,500 + delegates in attendance for conference was strong revenue generated for the organization. The CEC 2012 Convention and Expo will be held April 11-14,2012 in Denver, Colorado. Leadership Institutes will be held July 25 – 27, 2011 with State/Provincial Leadership Institute with Division Leadership Institute July 27 – 28, 2011

Day 2 – a quorum was determined and discussion occurred around the following topics: Future Representation Assembly Meeting Schedule During the Annual Convention & Expo from a 2 day to a 1 day seem to be the consensus; Nominations Standing Committee Nomination and Election Procedure; Identification of Representative Assembly Future Discussion Topics; Emerging Professional Issues; and Member Needs and Concerns. Emerging issues brought to the floor included: Emerging Professional Issues: Child Abuse & Neglect in special education; mentoring; alternative licensure; and lack of support for pre service education. The results of these discussions were forwarded to the Board of Directors for further action.

#### **AWARDS**

The Council for Exceptional Children offers the following **three annual award** programs. All winners are acknowledged at the CEC Annual Convention & Expo, held every April. Please nominate a deserving individual.

The CEC Professional Awards recognize special educators who have advanced the field and the quality of special education service as well as CEC members whose contributions have moved the Council forward in significant ways. They include the CEC J.E. Wallace Wallin Lifetime Achievement Award, the Clarissa Hug Teacher of the Year Award, the CEC Special Education Research Award, and the Outstanding CEC Leadership Award. Nominations are now open and due Oct. 21!

The CEC Student Awards and Scholarships recognize CEC student members and faculty advisors who have made outstanding contributions to the organization and to exceptional children. They include the Outstanding CEC Student Member of the Year Award (undergraduate and graduate), the CEC Graduation Award (undergraduate and graduate), the Kayte M. Fearn CEC Ethnic Diversity Scholarship, and the Susan Phillips Gorin Award. Nominations will open in August 2011.

The Yes I Can! Awards honor children and youth with disabilities (ages 2-21) who have excelled. CEC selects winners for their outstanding achievements in one of seven categories: Academics, Arts, Athletics, School and Community Activities, Self-Advocacy, Technology, and Transition. Nominations are now open and due Oct. 21!

# Preserving CEC History and Linking to the Future Important CEC-PD Activity

The June Jordan Fund was established in 1994, by the Pioneers Division in honor of June Jordan who was a former CEC staff member. June was instrumental in providing the leadership and support for establishing the Pioneers Division. In addition, she led CEC in the collection of documents and other types of information of historical significance to CEC and the field of special education. The official title of the fund is "The June Jordan 'I have a Dream' Memorial Fund". The purpose of the fund is to support The Council for Exceptional Children in maintaining the Archives and history of the Council. The Archives are maintained by a CEC Archivist who has a non-voting position on the CEC-PD Board. The Fund is financed through direct contributions to the Fund. These funds are then allocated for expenditures to support the expansion and maintenance of the CEC Archives. In the past, the support for the CEC Archives has consisted of providing dollars from the June Jordan Fund to purchase supplies needed by the CEC Archivist, and to provide assistance to the Archivist by other members of the Pioneers Division in preparing and in placing materials in the CEC Archives from time to time. It is hoped that the plan developed by the History Initiative Work Group will provide additional opportunities to share, as well as, preserve the history of CEC and CEC-PD. Mackie Award for Outstanding Leadership, Delegate to the White House Conference on Handicapped, ISBE Outstanding Administrator Award, ICEC Meritorious Service Award, ILDA Leadership Award, ILDA Outstanding Administrator Award, Waukegan Public Schools Excellence in Administration Award; and
