Finally, written comments were sent to CEC on the proposed revisions to the CEC Constitution and Bylaws (a copy of the comments are included in this newsletter). The PD was also able to gain the support of the Interdivisional Caucus in asking the Board to consider not adopting the recommended changes to the Constitution and Bylaws until further study of the governance structure of CEC can be completed by an appointed committee. We have not yet heard back from the Board regarding this request.

So, as you can see, the PIONEERS continue to be actively involved with CEC initiatives, committees and providing services to the special education community. If you have any questions, concerns or suggestions for any of the PD Board members, please feel free to send them to me for a response.

2015 CEC Leadership Institute Update

On July 12, 2015, CEC-PD President, Michael Thew, provided a brief report to CEC-PD Board members on some of the events of the 2015 CEC Leadership Institute in Washington, DC. He wrote that, "this afternoon we had a very short Inter Divisional Caucus (IDC) meeting led by Chair, Bill Bogdan. I presented a written summary of the PIONEER Division concerns with the Proposed Amendments to the CEC Bylaws (see page 4) along with a motion asking the IDC to request that the Board of Directors (BOD) only take action on those amendments that are needed to bring CEC into compliance with the District of Columbia Non Profit Corporation Act. In addition, I requested that the BOD, through the President, appoint a work group, chaired by a non-BOD member, with representation of the CEC membership, governance, the Representative Assembly (RA), State and Provincial Units and Divisions. The charge would be to review the current governance of CEC, since it has not been reviewed in approximately 15 years."

There was a brief discussion of the concerns during which time both CEC President, Jim Heiden and President-Elect, Antonis Katsiyannis, shared their thoughts on the proposed amendments. They both stated they did not support the amendment that would automatically place BOD members on the slate and not have them be vetted per the Nominations Committee protocol. President Heiden also stated that he viewed the amendments as a "first draft" that all members/ divisions/ states and provincial units are encouraged to comment on until July 27th. He further stated that the comments would be summarized and shared with the BOD and then revised and then made available for more comment based on the revisions made by the BOD before final adoption. After hearing the comments I was asked if I still wanted the motion on the floor to be brought forward and voted on. I requested that the vote be taken. The vote in favor of the motion passed on a voice vote with only one "no" vote.

There are copies of PowerPoints presented at the CEC Leadership Institute sessions. They are posted on the CEC website under the Membership tab, then click on Leadership, then Leadership Institute resources/ materials.

It is noteworthy that the PIONEERS were highlighted during the Institute by Executive Director Alex Graham and President Jim Heiden for our collaboration on the Mentor Program and for the new work on the Bright Futures Study.

Comments on the Proposed Amendments to the CEC ByLaws

The PIONEERS Division provides the following comments on the proposed CEC ByLaws Amendments. Questions concerning the comments may be sent to Michael D. Thew, President, PIONEERS Division, mdthew@gmail.com

The PIONEERS Division understands the need to review and revise the current Constitution & ByLaws to comply with the laws of the District of Columbia Non Profit Corporation Act. However, after review of the proposed amendments we find that not "all" of the proposed amendments are needed to be in compliance with the Act. Furthermore, the ByLaws Amendments will eliminate the Constitution of the Council for Exceptional Children and place all of the State, Provincial Units and Divisions out of sync with the National organization, creating more burdensome work to realign them with CEC again.

The comments / concerns with the proposed amendments to the ByLaws are outlined by the bulleted items below:

- The proposed amendments lack a rationale or summary of their intent with the administrative and financial impact as required under the current Constitution and ByLaws (C&B) Article XII, Amendments, Section 2 b.
- The proposed amendments change CEC from having a Constitution and ByLaws to only having a set of ByLaws. Why this is proposed is not stated or explained clearly. If adopted, all the State, Provincial Units and Divisions will need to expend time, effort, resources and funds to follow suit.
- The proposed amendment for Article V, Section 3 a, Section of Members of Board of Directors provides the current Board of Directors members automatic rights to be placed on the slate while "regular" CEC members must be processed through the nominations committee. This change creates different processes for nominations and grants BOD members privileges and greater rights over regular members.
- The proposed amendments place the BOD in control of the affairs of the CEC with no input from States, Provincial Units or Divisions. This is done by taking away the rights of the Representative Assembly (RA) to vote on changes affecting the rights, benefits and services for States, Provincial Units and / or Divisions.
- The proposed amendments mandate that candidates for the unfulfilled term of President-Elect can only be selected from the BOD members, thus eliminating candidates from the general membership ranks or leaders from State, Provincial Units or Divisions.
- The proposed amendments remove the right of the RA to take action for removal of a member of the BOD for "cause".
- The proposed amendments to Article XIII Parliamentary Rules, changes the word "govern" to guides. This change of verbs gives the BOD full authority to conduct the business of CEC without regard for a specified "Rules of Order" to be followed. Robert's Rules of Order uses the word GOVERN, anything else does not ensure that a "set of rules" will be used or followed.
- Finally, Article VI, Section 7 e gives the sole right to approve amendments to the Articles of Incorporation, the Constitution and ByLaws and CEC policies that affect the privileges of any CEC unit to the RA. This brings up the question of, how then can the BOD take action to delete this section of the Constitution and ByLaws as it would directly affect the "privileges" of units and under the current Constitution cannot be done? The same would be applicable for Article XI Amendments, Section 2, c-f.

In summary, the PIONEERS Division has provided a list of concerns with the proposed Amendments to the ByLaws for review. As further input into this very important issue, we strongly recommend the following:



- 1. Only adopt those changes that must be made to bring CEC into compliance with the DC Act for Non Profit Corporations. Do not adopt any other proposed amendments until a full review of the Governance of CEC can be completed by a work group appointed by the BOD.
- 2. The Governance review work group should be chaired by a non-BOD member and be broad in membership to include members from the BOD, RA, State / Provincial Units, Divisions and the Executive Director or designee, with support from CEC staff.
- 3. The Governance work group should be charged with doing a complete, in-depth review of the Governance of CEC to include BOD functions, the RA, Work groups, etc.
- 4. Once the work group review is completed and a report provided back to the BOD, then the revising of the Constitution and ByLaws can be completed to reflect the recommendations adopted for the overall Governance of CEC.

Thank you very much for the opportunity to provide feedback and suggestions for helping to move CEC forward with its Governance.

In Memoriam: Lynne Cook



Dr. Lynne Cook was a member of the Department of Special Education at California State University, Northridge from 1980-2006, serving as Chair in 1985. She quickly established a prolific record of scholarship, to include co-authoring *Interactions: Collaboration Skills for School Professionals* with Dr. Marilyn Friend. Now in its 7th printing, *Interactions* is the most widely used textbook on the topic of collaboration. Lynne established an extraordinary record of service throughout the California State University system, as well as nationally and internationally. In recognition of her outstanding and exemplary contributions to CSUN, Lynne received the University's Faculty Award for Distinguished Teaching. Lynne left CSUN in 2006 to assume the position of Dean in the College of Education at CSU Dominguez Hills. She was awarded emeritus status at CSUN this year.

Lynne served as President of the Teacher Education Division (TED) of the Council for Exceptional Children (CEC) in 1997-1998. Based upon her seminal work on teacher shortages in special education and her work on co-teaching, she was awarded the TED Pearson Excellence in Teacher Education Award in 2008. Lynne was married to Fred Weintraub, another well-known leader in special education and CEC and one of the creators of PL 94-142. Fred passed away in May 2014.

Lynne was an internationally recognized expert in special education who throughout her exceptional career made a significant difference in the lives of individuals with special needs and their families. Many members of the Teacher Education Division knew her as a leader, mentor, teacher, visionary, scholar, big picture thinker, and incredible friend. She helped shape teacher education in special education and we will be forever grateful. Lynne, you will be sorely missed

"Bright Futures" Revisited

Representative Assembly and Pioneer Division Showcase Session 2015 CEC Convention

During the 2015 CEC Convention and Expo in San Diego, CA, CEC members began a discussion examining the benefits of updating the 1998 Bright Futures study. The original Bright Futures study reviewed the "conditions of teaching" students with exceptionalities and offered recommendations for improvements. With 17 years since the study completion is it time to revisit the work to see what things have changed?

Representative Assembly (RA) members for CEC units and divisions are a distinguished group of individuals who serve as a unique leadership body for the field of Special Education. They come from across the US and Canada and hold leadership positions in divisions and/or State and Provincial Units, focused on exceptionalities including disability areas, gifted and talented, young children, and culturally diverse students. The RA members serve as advisors to the CEC Board of Directors. During the 2015 RA meeting, RA members participated in round-table discussions of the following questions:

- What would be the benefits of a new study of special education teaching conditions?
- What societal trends are influencing education today?
- What societal/educational trends are influencing special education?
- What barriers currently affect high quality-special education?
- What are positive enablers that support high-quality special education today?

In addition to the RA discussion, four of these questions were explored in depth during the Pioneers Showcase session and these results are included as a comparison sample of CEC membership. The RA and Showcase discussions were facilitated by members of the Pioneers Division and CEC Past Presidents. Notes were collected and responses were compiled and placed in rank order according to the number of times each response was mentioned. These were reviewed for comprehensiveness and accuracy by 5 members of the Pioneers Division who participated in the RA and/or Showcase sessions. In this summary we will focus on the answers that were most frequently given, the top 5-6 responses, however the full set of comments will be used as this work moves forward (the full response-set is available in Appendix A)). The top responses for both the RA and Showcase are presented in Table 1.

RA members indicated that an update of the Bright Futures study would help us respond to today's teacher and student populations whose needs and interests reflect the "millennial" generation. Other benefits included the ability to compare the conditions of teaching across time periods, and the ability to use findings from the study to influence policy, teacher preparation, and practice. They felt that an updated study would position CEC for continued leadership on issues within Special Education that need to be addressed.

Education does not take place in a vacuum and societal trends often impact the direction and context of educational policy and practice. The RA and Showcase responses were similar in the social trends they identified. The change in demographics with increases in children of color, linguistic diversity, and poverty was a key factor cited by both groups. The increased use of technology and social media both for communication and for education was included as a key trend. Both groups cited the increased role of privatization of school and the "for profit" movement within special education combined with general concern over funding patterns and shortages for public

patterns and shortages for public education. Changes in family structure and the impact this has on keeping families engaged with their child's education was mentioned by both groups. Members of the RA also included concerns about growing negativity of the public's perception of education in their top societal trend impacting education today.

When asked about educational trends that are effecting special education specifically the most frequent response was the movement toward accountability for student outcomes with increases in the use of high-stakes testing, growth-models for tracking student progress, and data-driven decision making. On the whole these responses indicated a positive impact for students with exceptionalities, but concerns were raised about appropriateness for students with significant areas of challenge. The common core and state curriculum standards were given as a major trend impacting special education and again the overall tone was encouraging with some disclaimers that the movement toward standards can be difficult when appropriate curriculum materials are not provided for students with exceptionalities.

Romaine P. Mackie Leadership Award

This Award was initiated in 1993 to honor a person who has demonstrated leadership over time in programs for exceptional children and youth. The Award was named for Romaine P. Mackie who was a U.S. Commissioner of Education and a devout supporter of special education in the very early years. She was a pioneer in the early development of special education as a profession within the field of education. Romaine Mackie was an active member of CEC and promoted the mission of the Council in all the work with which she was involved. She provided leadership for the development of a section within the U.S. Department of Education designated for special education. For these reasons, the Pioneers Division established the Award in honor of her impact on the field. The Award honors an individual who best represents leadership in the field of special education. This award in the form of a selected commemorative item is presented at the annual CEC Convention and Expo.

Criteria

- Length of service in the field
- Documentation of continuous leadership during the time span of the nominee's career
- Leadership position within the various units of CEC (state/provincial, chapter, subdivision, division)
- Leadership positions at the national level in CEC
- Leadership positions in other related organizations / associations
- Acknowledgement by others of the nominee's leadership (letters of support, other awards/honors bestowed)
- Significance of leadership contributions made
